## Question#1

1. In section 5.6 Firing Site it is stated that the Township shall provide an adequate firing site located at the Green Acres Facility, Piscataway, N.J. It shall be the Township's responsibility to secure the site prior, during and after the fireworks display. In section 10.0, "Storage and Security at the Display Location", it is stated in 10.1 that in the event of a postponement by the Township the security for the fireworks will be provided by the

section 10.0, "Storage and Security at the Display Location", it is stated in 10.1 that in the event of a postponement by the Township the security for the fireworks will be provided by the Townships' Police Department. In 10.2, the only exception that the fireworks are to be left unattended, is when the event is postponed by the Township and the Police Department assumes security. This conflicts with 10.6, which states that in the event of a rainout, the operator must supply security of any materials.

As such, please clarify the responsibility of security.

#### ANSWER #1:

The first question postponement by the Township does not include rain it would be for other Township related reasons. Rain postponements are agreed to by the Township and the Vendor.

If vendor postpones due to any reason and/or weather, security is vendor responsibility. If the Township postpones for any other reason, security is township responsibility.

### Question#2

2. Please clarify the following statement in "17.2 Shell Count:" "The assortment of shells and mines must not exceed 280 foot in distance."

Is this regarding vertical height of pyrotechnic effects or regarding distance from the audience? Further, the Shell Count provided does not include "mines" are these a requirement of the proposal response?

#### ANSWER#2

The second question the 280 foot distance is a Fire Marshal requirement from the state of NJ that was added in 2019. There currently are no mines in the shell count it is just wording to give the Township the ability to add additional items to the original proposal
