ANNOUNCEMENTS & COMMENTS FROM OFFICIALS:

Gabrielle Cahill wished everyone a Happy and Healthy New Year.

Township Attorney Raj Goomer arrived at the meeting at 6:46 pm

Steve Cahn wished everyone a Happy New Year and thanked, in advance, the volunteers appointed to the Boards and Commissions for their anticipated service to the town.

Michele Lombardi thanked the volunteers. It is truly what the fabric of our town is. She wished everyone a Happy and Healthy 2018. She read a quote: Although no one can go back and make a brand new start, anyone can start from now and make a brand new ending

Kapil Shah wished everyone a Happy New Year.

Frank Uhrin wished everyone a Happy and Healthy New Year.

Mayor Wahler agreed with what everyone said.

Chanelle McCullum wished everyone a Happy New Year. She also reminded everyone that the Piscataway Civil Rights Advisory Commission and the North Stelton AME Church Women's Ministry present an annual event; the Dr. Martin Luther King Jr. breakfast. It will be held Saturday, January 13th at the Piscataway Senior Center at 8:30 am.

OPEN TO PUBLIC:

Tess Borden, an attorney with the ACLU, 89 Market Street, Newark, NJ, wished everyone a Happy New Year. She thanked the Council and commended the Council for the opening statement and recognizing that the current code is out of date and that the Council is undertaking a revision of the code with regard to recording of public meetings. She encouraged the Council to be a model, to commit to open government and transparency. She commented this is a problem they are on record about not only in this town, but in others and this is not a unique problem. She thanked the Council for the opportunity to speak.

Staci Berger, 233 Ellis Parkway, wished everyone a Happy Healthy New Year. Ms. Berger stated she was threatened with removal and arrest at the last meeting for exercising her legal right to record the proceedings. She thanked the team at the ACLU for helping the Council see that this ordinance is unlawful. She is thrilled that the Council chose not to enforce it and she looks forward to it being repealed and replaced with rules that do not overstep authority or attempt to hide business from the open public meetings act. She commented about New Year's resolutions and hopes the Council members resolve to make Piscataway's operations and government more open, transparent and accountable to the residents. There's no reason Council meetings, Zoning Board, Planning Board meetings, committee meetings, couldn't be publically recorded and broadcast. She asked why meeting agendas and minutes, budgets and audits and the master plan aren't readily available online. She commented the Council should have been fighting for the residents of Ward 3, instead of taking the side of the developers of a 78 bay tractor trailer warehouse. She commented the Council should be representing the residents of Ward 1, who want the Police sub-station re-opened and improved community safety in their neighborhood. She commented that any Council

members could be standing up for residents across Piscataway who don't want property revaluations every couple of years. She also commented about what happened to the money donated for pavers and other fundraisers for the Y that was never built. She further stated people come to the meetings or reached out to Council members and asked for their leadership and have been ignored or maligned. She commented about Council members asking for votes and support each June and November, but then won't be their voice. Ms. Berger stated the Council are personally insulted when people exercise their right to run for office, or campaign for others as though the Council members are entitled to run unopposed. She commented that respect is deserved and expected even if the Council disagrees. She stated everyone has the right to run for office, come to Council meetings and video tape it if they want to. It's democracy and it's everyone's responsibility to protect it. We want leaders to stand up for us. It's one reason the council meeting was attended two weeks ago and she states it was disappointing to see the Council Members wring their hands and say nothing could be done. She stated the profits of Penford Group were put above the well being of the residents. She commented it was shocking to see the Council's total disregard for the rights of the people they are elected to represent. She stated that the all Democratic Council should be on the front lines of transparency, openness and community engagement. She stated the Council should be seeking out opportunities to fight for resident's interests and rights, not attacking them. The interests and needs of residents should be put first. She stated these would be good resolutions for the Council for 2018.

Rajvir Goomer commented for the record that Ms. Berger wasn't threatened with arrest; she was asked to stop recording or she would be removed from the room. Mr. Goomer also stated that the case law was provided and it is being looked into, due diligence is being performed as ordinance amendments are being prepared.

Jen Cooms, no address provided, stated she is part of the media. She came into the Piscataway Municipal Complex last week to video tape and didn't know what to expect. She stated she is a first amendment advocate also. She commented she didn't know what to expect and found the employees to be very professional, including the law enforcement department. She met Captain McLaughlin who was very nice. She commended the Council for seeing the mistake; there could have been legal ramifications.

There being no further comments, this portion of the meeting was closed to the public.

There being no further business to come before the council, the meeting was adjourned at 6:56 pm on motion of Mrs. Lombardi, seconded by Mr. Bullard, carried unanimously.
