ANNOUNCEMENTS & COMMENTS FROM OFFICIALS:

Chief Scott Cartmell addressed the public regarding the Police Department being the first on scene in an emergency. He explained that many lives are saved by Police officers who are on the road and respond to emergency calls and administer CPR and or AED. He further explained the lives saved from overdose by Police officers administering Narcan. He gave statistics regarding the lives saved over the past three years by the Police Department. He mentioned again the Police Department is the first on scene and discounted the comments previously made that lives are being lost.

Lt. Thomas Mosier advised he is the Traffic Safety Division Supervisor and he is also the EMS, Fire Department and Emergency Services liaison for Piscataway. He advised the protocols are sound and the dispatchers do a fantastic job in a high stress and high impact situations. Lt. Mosier advised that a letter from the Mayor that was referenced at a prior Council meeting was written solely in support of River Road Rescue Squad's actions to bill the patients they transport through their insurance companies. It wasn't written to limit the Mayor or Chief's authority in dispatch protocols. Lt. Mosier explained that the statements made at a previous meeting regarding two persons who lost their lives were false. It was tragic and to indicate those calls resulted in a death is simply a play on words. There were no human errors or errors in protocol in those deaths. He explained the time lines associated with the calls. He advised the protocols and responses are sound.

Steve Cahn commented there are terrific Police officers in town that respond to different emergencies and are first to arrive and take control of chaotic situations. He is proud of our Police Department.

Jim Bullard commented that he is proud of the Police Department for all they do.

Chanelle McCullum thanked the volunteer firemen and rescue squads for all they do. She felt it is important to clarify the situation. She thanked Chief Cartmell and Lieutenant Mosier for coming and clarifying.

Michele Lombardi thanked the Chief and Lieutenant for coming and clarifying those times. There is no discredit to any of our volunteers.

OPEN TO PUBLIC:

Ken Simmons, Tap into Piscataway, asked with the use of services from RWJ, are there any charges to the Township?

Chanelle McCullum advised the patients receive a bill from RWJ.

Mr. Simmons asked about the agreement; is there a financial arrangement?

Rajvir Goomer advised there was an open public bidding process; the Township doesn't pay a dollar amount.

Mr. Simmons commented that this is to assist the EMS services already in town already; not take the place of.

Mr. Cahn advised the problem was not having enough EMT volunteers to cover 24 hours a day. This is a supplement for when volunteers can't cover.

Evan Shegoski, Chief of River Road Rescue, 101 Shirley Parkway, commented that the Township pays over \$20,000.00 per year and it increases every year. He thanked Mr. Dacey for meeting with him to clarify the documentation required for the yearly contribution. He commented that the Township pays quarterly for weekend coverage too. He spoke about the emergency services meeting that took place and Lt. Mosier advised they have the schedule and have never had a problem knowing whether River Road was in or out of service. He advised the OEM Coordinator advised RWJ will be stationed at the Rushmore Ave. location to service South Plainfield, he doesn't understand why that is being done.

Timothy Dacey explained they have predictive software and asked to be stationed in that area.

Mr. Shegoski commented that the Chief said a lot about what the Police do, he thinks it's fantastic that they help, but didn't talk about what EMS does. There were no EMS numbers brought up. He explained that he didn't say that anyone caused anyone's life to be lost. He believes it could be better if they are dispatched from a crew in house.

David Akins, 39 Ambrose Valley Lane, asked about item L, is this for 139 School Street?

Mayor Wahler advised this is for advertising for Phase 2 of the School Street improvements.

Mr. Akins asked about the Township purchasing 139 School Street.

Mr. Goomer advised the Township owns that property and it will be auctioned.

Mr. Akins asked about an item on the agenda at the last meeting, authorizing change order #1, restroom renovations, not to exceed \$7,858.00, what did they find?

Mrs. McCullum advised she doesn't have the information in front of her, so she'll have to get back to him.

Mr. Akins asked about another item from last week, community center, construction management, Cumming Construction Management, what are they doing?

Mr. Dacey advised the plans and site work are being finalized and getting ready to bid the project sometime this summer. Cumming will handle coordinating the project prior to bidding, assist with the bidding process and will handle the construction management once the project is awarded.

Junior Romero, Food and Water Watch, 200 Bayard Street, New Brunswick, NJ, advised he is here to advocate for an off fossil fuels resolution. He asked the council to support the cause and adopt a resolution.

Mr. Cahn advised that the Township is a component of that with existing and some proposed solar power.

Staci Berger, 233 Ellis Parkway, advised she reviewed the minutes from January 2nd meeting and she is thrilled to see the second reading of the video tape ordinance coming up. She doesn't understand why things can't be put on the website, why things were taken down, that there are no email addresses for the Council any longer. It appears that things are less transparent now. Things should just be available to people like agendas, minutes, resolutions.

Jim Bullard advised we are taking a look at our website and updating it currently.

Tony Weil, 2250 Plainfield Avenue North, commented that hundreds of pages and transcripts could be put on the website at no cost. Other municipalities are video taping their meetings. People being more educated on government can't be a bad thing. Mrs. McCullum commented these are things we are looking into.

There being no further comments, this portion of the meeting was closed to the public.
