WHEREAS, the Township Council of the Township of Piscataway has reviewed the aforesaid preliminary investigation report and the Piscataway Township Planning Board Resolution adopted and memorialized on April 11, 2018;

NOW THEREFORE, BE IT RESOLVED by the Township Council of the Township of Piscataway, County of Middlesex, State of New Jersey, that the Piscataway Township Council concurs with the determination of the Piscataway Township Planning Board, that the property identified in the Study Area referred to in the aforesaid Planning Board Resolution and the James F. Clarkin IV, PP, AICP report, is an area in need of redevelopment as defined in N.J.S.A. 40A:12A-1 et seq., and hereby directs the Piscataway Township Planning Board to prepare a Redevelopment Plan for the Study Area; and

NOW, THEREFORE, BE IT FURTHER RESOLVED that the Study Area evidences conditions which fall within certain criteria set forth in the Local Redevelopment and Housing Law, specifically criteria (b) and (d); and

NOW, THEREFORE, BE IT FURTHER RESOLVED that the Study Area shall continue to be reviewed as a Non-Condemnation Redevelopment Area.
