WHEREAS, pursuant to a letter from CME Associates, dated June 21, 2018, a price for the Project was negotiated with T.R. Weniger, Inc., Piscataway, NJ who agreed to perform the Project for a total amount not to exceed \$2,561,990.00; and

WHEREAS, funds are available pursuant to certification # B-2018-025; NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Piscataway that pursuant to N.J.S.A. 40A:11-5(3), the appropriate municipal officials be and are hereby authorized to award a contract for the Police Vehicle Canopy Project to T.R. Weniger, Inc., Piscataway, NJ for a total amount not to exceed \$2,561,990.00, subject to all bid specifications and contract documents.

Steve Cahn thanked the Mayor for his involvement with the US Conference of Mayors who have taken the lead on this issue. This is something very important and he's glad to be doing this resolution.

RESOLUTION #18-295

RESOLUTION offered by Mrs. Cahill, seconded by Mr. Bullard, BE IT RESOLVED, By the Township Council of Piscataway Township, New Jersey that:

WHEREAS, considerable attention has been paid to the plight of children at the Southern border and the New York Times recently reported that the Department of Health and Human Services (HHS) had confirmed that the Department of Homeland Security (DHS) has separated more than 700 children from their parents since October 2017, including more than 100 children under age four; and

WHEREAS, the Department of Justice has adopted a "zero tolerance" policy toward individuals apprehended at the border, which calls for the prosecution of all migrants entering the United States outside of ports of entry and the resulting forced separation of many children from their families; and

WHEREAS, the new policy establishes that for parents and caregivers who are processed in the criminal court system and held in federal jails, their children will be classified as unaccompanied minors and housed in shelters awaiting placement with a US-based adult who can assume their care and if the Office of Refugee Resettlement (ORR) cannot locate a US-based adult able to care for the child, the child will stay in federal custody, separated from family, indefinitely; and

WHEREAS, according to media reports, the number of children in HHS custody has grown by nearly 2,000 over the past month alone, shelters for migrant children are reportedly at 95 percent capacity, and HHS is preparing to add potentially thousands of beds in the coming weeks to accommodate the rising number of detained children; and

WHEREAS, many of these families are fleeing violence in their home countries, and it is inhumane to punish them for seeking safety and invoking their right to seek asylum in the US; and

WHEREAS, by adopting a policy that forcibly separates immigrant families, DOJ and DHS fuel the climate of hostility experienced by many immigrants and refugees residing here, which causes many to feel alienated and avoid contact with government agencies, which impacts public safety; and

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Piscataway that the Township of Piscataway registers its strong opposition to separating children from their families at the border and calls on the Department of Homeland Security and Department of Justice to immediately reverse these destructive policies and allow families apprehended to remain together to the extent possible, to help avoid the heartbreak and irreversible trauma of forced separation; and

BE IT FURTHER RESOLVED by the Township Council of the Township of Piscataway that the Township of Piscataway urges Congress to take action immediately to ensure that the Department of Justice and the Department of Homeland Security are prohibited from this wholesale separation of children from their families at the border; and

BE IT FURTHER RESOLVED by the Township Council of the Township of Piscataway that the Township of Piscataway supports the Resolution of the U.S. Conference of Mayors at its 86th Annual Meeting opposing the above referenced Department of Homeland Security policies.

On roll call vote, Messrs. Bullard, Cahill, Cahn, Lombardi, Shah, Uhrin and McCullum answered yes.

RESOLUTION offered by Mr. Bullard, seconded by Mrs. Lombardi, BE IT RESOLVED, by the Township Council of Piscataway Township, New Jersey that: AN ORDINANCE ENTITLED: BOND ORDINANCE PROVIDING FOR THE COMMUNITY CULTURAL ARTS CENTER PROJECT IN AND BY THE TOWNSHIP OF PISCATAWAY, IN THE COUNTY OF MIDDLESEX, NEW JERSEY, APPROPRIATING \$39,000,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$37,050,000 BONDS OR NOTES OF THE TOWNSHIP TO FINANCE PART OF THE COST THEREOF be and is hereby adopted on the first reading, that it be published in the official newspaper, and that a second reading and public hearing be held at 7:30 p.m., prevailing time at the Piscataway Municipal Building, 455 Hoes Lane, Piscataway, New Jersey on the 24th day of July, 2018.

Michele Lombardi reminded everyone about many things happening over this 4th of July weekend; the Metlar House, East Jersey Olde Towne and the annual fireworks display. She wished her colleagues a Happy Birthday and she wished everyone a safe and happy 4th of July.

Kapil Shah wished Frank and Steve a Happy Birthday.

Frank Uhrin wished Steve a Happy Birthday.

Mayor Wahler announced that the Township was recently notified by the DEP that the water treatment permit was received for the community center.

Chanelle McCullum reminded everyone of the upcoming first summer concert on July 5th, Jim Barrone.

OPEN TO PUBLIC:

Anthony Weil, 2250 Plainfield Avenue North, applauded the council for opposing the separation of families. He feels this resolution is a step that every town needs to take. He thanked the council. He asked about the status of the fair and welcoming resolution that was discussed months ago.

Rajvir Goomer, the Council is supportive of making sure that the policies of the Township are protective of the residents. He has been working with the Chief of Police to make sure there are written policies to protect the residents and that the officers know the protocol when dealing with ICE.

Steve Cahn commented about speaking with the Chief of Police who is currently attending a conference with this as one of the topics. He also mentioned that absent a legal court order, the Township will not get involved in an immigration issue.

Mr. Weil encouraged the council to pass the resolution, it's a statement.

Mr. Weil commented about an upcoming event, Families Belong Together, which will take place at 9:30 on the 30th at the Municipal Building.

Mr. Weil commented about having a problem on the 19th with diesel fumes in his yard, there were idling trucks. He was advised previously to contact the police and they

asked him if he needed an ambulance and if not, he shouldn't be contacting 911. Mr. Weil indicates he contacted NJDEP and Middlesex County health inspectors came out. He feels the police should have come out and could have cited them for idling. They were guaranteed the developer, the Penford Group, would take their health and issues into account. He asked about he parking on Plainfield Avenue and the privacy hedge.

Mr. Goomer advised he is still working with the traffic division.

Frank White, 607 Ellis Parkway, asked about the entrance for 800 Centennial Avenue being on Centennial Avenue.

Steve Cahn advised they are working on that with them; there are some logistical challenges that we're hopeful to work that out.

Mr. White asked when the demolition and construction will be complete.

Timothy Dacey advised the demolition and clean up should be done in July and site work and construction completion is anticipated in January.

- Mr. White commented that there are cities that have already created fair and welcoming policies and the Township can take and edit as needed.
 - Mr. Cahn advised some cities are being sued by the Federal Government.
- Mr. Goomer commented that he has spoken with the ACLU and the Chief of Police on a written policy.
 - Mr. White asked if the audited budget for 2017 is on the internet.
- Mr. Dacey advised it will be at the next meeting; it is due June 30th and will be posted after the Council approves it at the July 10th meeting.

David Akins, 39 Ambrose Valley Lane, asked about item 7a, will this conclude all the work for HVAC and include all buildings.

- Mr. Dacey advised this is only for the Municipal Building. It is expected to do some minor work in the Police Department next year.
 - Mr. Akins asked for an elaboration on items I, j, k and L.
- Mr. Goomer advised this is a grant for individuals for assistance for affordable housing and is income based.

Curtis Grubbs, 1750 West 3rd St., asked about item h, 88 Centennial Avenue, how long does it take to condemn a piece of property.

- Mr. Goomer advised it is being designated as a redevelopment area. It depends on the discussions with the property owner, there is no defined timeline.
- Mr. Grubbs asked about the house on South 2nd Street that was demolished, who will cut the grass on the property.
 - Mr. Goomer responded the bank; he will reach out to them.
 - Mr. Grubbs asked about the re-seeding of Hazelwood Park.
- Mr. Dacey advised he spoke to guy who advises this was not promised to be reseeded.

Mayor Wahler advised it will be hydro seeded in the Fall.

Mr. Grubbs asked about the property across from Hazelwood Park, who is responsible for cutting that.

Mayor Wahler advised that is the corporation property, they are responsible.

There being no further comments, this portion of the meeting was closed to the public.

There being no further business to come before the council, the meeting was adjourned at 8:00 pm on motion of Mrs. Cahill, seconded by Mr. Cahn, carried unanimously.
