November 22, 2022

A Regular Meeting of the Piscataway Township Council was held on November 22, 2022 at the Piscataway Municipal Building, 455 Hoes Lane, Piscataway, New Jersey. The meeting was called to order by Council President, Michele Lombardi, at 7:30 pm.

Council President Lombardi made the following Statement, in compliance with the Open Public Meetings Act: Adequate notice of this meeting has been provided as required under Chapter 231, P.L. 1975, specifying the time, date, location, login, or dial in information, and, to the extent known, the agenda by posting a copy of the notice on the Municipal Building, Municipal Court and the two Municipal Library Bulletin Boards, Municipal Website, providing a copy to the official newspapers of the Township and by filing a copy in the office of the Township Clerk in accordance with a certification by the Clerk which will be entered in the minutes.

The Township continues to use a remote meeting format in an effort to mitigate the chance of exposure to COVID-19, as a part of the Township's ongoing effort to slow the rate of transmission and avoid overwhelming our treatment centers.

In order to make sure a clear record of the meeting can be made and that all parties are heard in an organized fashion, all members of the public will be muted during the meeting. If a member of the public wishes to speak during any public comment portion, please raise your hand. This can be done either through the zoom app or by pressing *9 (star nine) on your phone. When it is your turn to speak, you will receive a prompt or request to unmute, please click on the prompt or press *6 (star 6) on your phone to unmute.

Upon being unmuted, you should begin to ask any and all questions you may have. You will have three minutes to speak, at the conclusion of which you will be muted again, and the council or administration will respond as necessary.

Should you have any further comments or questions, the Township Council is always available by email and phone, and you can always call the Mayor's office during normal operating hours. Each member of the public shall only have one opportunity to speak during each public portion. As the technology does not allow us to know if there are multiple callers on an individual phone line or logged in user account, we ask that if you wish to speak, that you login in or dial in separately so that we can recognize you as a separate individual.

Individuals may also submit written comments to the Township Clerk up to fortyeight (48) hours prior to the meeting, to be read by the Township Clerk during the Public Comment Portion of the meeting. Said comments shall be limited to three minutes of reading.

WHEREAS, the Township Council (the "Township Council") of the Township of Piscataway (the "Township"), pursuant to the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1 et seq., as amended and supplemented (the "Redevelopment Law"), adopted a redevelopment plan (the "Redevelopment Plan") for the redevelopment of an area of the Township commonly known as 330 South Randolphville, Piscataway, New Jersey, and designated as Block 4701, Lot 5.05, as shown on the tax maps of the Township (the "Redevelopment Area"); and

WHEREAS, on June 4, 2020, the Township Council adopted Resolution No. 20-214 designating 330 S. RANDOLPHVILLE URBAN RENEWAL, LLC, a New Jersey limited liability company, with offices located at 160 Park Avenue, Florham Park, New Jersey 07932 (the "Assignor"), as the Redeveloper of the Redevelopment Area and authorizing the execution of a redevelopment agreement; and

WHEREAS, on August 24, 2020, the Township and Assignor entered into a redevelopment agreement (the "Redevelopment Agreement") to implement the Redevelopment Plan; and

WHEREAS, the Assignor, as the Redeveloper, obtained approvals for the development of the Redevelopment Area with two (2) light industrial warehouse buildings with a combined floor area of approximately 298,313 sq. ft., driveways, and motor vehicle parking areas (the "Project"); and

WHEREAS, the Township entered into a financial agreement with the Developer dated August 24, 2020 (as may be amended from time to time, the "Financial Agreement"), which provides for a long term tax exemption and payment in lieu of taxes to the Township in connection with the Project and in accordance with the Long Term Tax Exemption Law, N.J.S.A. 40A:20-1 et seq. (the "Exemption Law"); and

WHEREAS, on November 23, 2021, the Governing Body introduced, and on December 14, 2021, adopted Ordinance No. 2021-40, adopting an Amended Redevelopment Plan, dated November 19, 2021 (the "Amended Redevelopment Plan"); and

WHEREAS, the Assignor has submitted written notice requesting the Township's consent to the assignment of the Redevelopment Agreement and the Financial Agreement to the Assignee; and

WHEREAS, the Annual Service Charge Start Date set forth in the Financial Agreement is scheduled to commence no earlier than January 1, 2023; and

WHEREAS, the Assignor desires and intends to transfer its rights, duties and obligations under the Redevelopment Agreement and the Financial Agreement with respect to the Project to PISCATAWAY LC URBAN RENEWAL LLC, a Delaware limited liability company with offices located at 40 East 52nd Street, New York, NY 10022 (the "Assignee") and the Assignee desires and intends to assume the same pursuant to a certain Assignment and Assumption Agreement and Estoppel Certificate, attached hereto as Exhibit A and incorporated herein; and

WHEREAS, after having considered the Assignee's background and qualifications, the Township wishes to approve the aforementioned Assignment and Assumption Agreement; and

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Piscataway, that the Mayor is hereby authorized to the attached Assignment and Assumption Agreement and Estoppel Certificate, attached hereto as Exhibit A, in substantially similar form as approved by the Township Attorney, and such other documentation as may be necessary to effectuate this Resolution.

RESOLUTION #22-365

WHEREAS, KM Construction Corp., Irvington, NJ entered into an agreement with the Township of Piscataway for the Leslie Avenue Improvements – Phase I (the "Project"), where KM Construction Corp would complete certain improvements at cost, in the amount not to exceed \$1,241,816.50; and

WHEREAS, as specified in the Change Order Form signed by the Supervisor of Engineering of the Township of Piscataway dated November 16, 2022, a copy of which is attached hereto and made a part hereof, there is a decrease in the Contract Quantities needed by the Township of Piscataway ("Township") for Leslie Avenue Improvements - Phase I; and

WHEREAS, this change order would represent a \$383,812.35 decrease in the amount of the contract from the previous total for a final cost not to exceed \$858,004.15, a 30.90% decrease from the original contract amount; and

WHEREAS, N.J.A.C. 5:30-11.3 authorizes a municipality to approve change orders up to twenty (20) percent increase of the originally awarded contract; and

WHEREAS, pursuant to a Final Change Order Form, dated November 16, 2022, from the Township Supervisor of Engineering, said Township Supervisor of Engineering recommends that the Township approve the Final Change Order Request; and

WHEREAS, funds are available pursuant to certification # B-2021-009;

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Piscataway, that the appropriate municipal officials be and are hereby authorized to amend the total contract amount for the Project with KM Construction Corp., Irvington, NJ from \$1,241,816.50 to a final total not to exceed \$858,004.15 and execute the enclosed Final Change Order in the amount of \$383,812.35, subject to all bid specifications and contact documents; and

BE IT FURTHER RESOLVED by the Township Council of the Township that the appropriate municipal officials be and are hereby authorized to accept the Project and return retainage funds to KM Construction Corp., Irvington, NJ, in the amount of \$17,160.08 upon KM Construction Corp posting a two (2) year maintenance bond in the amount of \$85,800.41 as it pertains to the Leslie Avenue Improvements – Phase I.
