MAYOR'S MESSAGE

SEEMINGLY WITHIN A BLINK OF AN EYE A NEW YEAR HAS BEGUN...

n behalf of the Township Council and myself I wish you and your families a most happy and healthy 2010! With each New Year comes the hope and promise of new beginnings and as we wish each other the traditional Happy New Year greeting we want this New Year, more than most, to bring positive changes not only for our families and friends but also for our state and our country.

It is a paradox that in the United States, according to the Department of Agriculture, we have a record number of households who were unable to get sufficient food at one time or another last year, and on the other hand, obesity, particularly in children, is a major health concern. It has also been reported that more than two-thirds of families with children who were defined as "food insecure" contained one or more fulltime worker. This suggests that lowwage earners have found it more difficult during these challenging economic times to provide their children with adequate nutrition. The Community Food Bank of New Jersey's CEO, Kathleen DiChara said, "In 30 years of doing this, I've never seen a time like this. The demand for food (in New Jersey) has increased 67%." Something is very wrong with this picture in a country as blessed as we have been.

In our own community, during the Thanksgiving season, our municipal employees, as well as several corporations and residents contributed to food baskets that were distributed to local families in Piscataway. We are very grateful for their generosity. I am also certain that our local churches were called upon to do the very same thing. And while people tend to be generous at

holiday times, please know that Piscataway receives requests throughout the year from local families in need of food. Our community is hardly immune from families in distress and children going to bed hungry. If during the year you are asked to help, please be as generous as you can. Hunger has no season.

I have recently signed on to The Mayors Wellness Campaign, an initiative of the N.J. Health Care Quality Institute in partnership with the N.J. State League of Municipalities. The ultimate goal is to increase opportunities for our residents to participate in daily physical activity with a long-term goal of improving health and reducing the skyrocketing health-care costs that come with the obesity problem in New Jersey. Obesity has become epidemic in American and in New Jersey and the consequences are startling! The obesity rate has doubled since the late 1970s and approximately 62% of U.S. adults and 34% of U.S. children are overweight or obese. Many scientists say that obesity, particularly among children, unless corrected, bodes poorly for the country's future. One in three U.S. teens is physically unfit. Studies show that eight out of ten



adults are likely to become overweight or obese as they age, putting them at a higher risk for hospitalization, diabetes, arthritis, and cardiovascular disease. Obese employees cost \$460 to \$2500 annually in medical expenditures and work absences and obesity adds \$93 billion to the nation's yearly medical care bill. Working with Councilwoman Michele Lombardi and others we plan to promote active living and healthy lifestyles through a variety of methods in the upcoming year within our community. Be advised that grass and vegetation waste will not be accepted at the Mini Dump/Recycling Center until Monday April 5, 2010. Coupons, for calendar year 2009 or calendar year 2010, will be required for grass and vegetation waste.

PISCATAWAY HEALTH DEPARTMENT INFORMATION

Due to a recent agreement with Middlesex County to provide certain health services, when calling the Health Department at 732-562-2323, you will be given several options. For information on obtaining a marriage certificate, press #1; Animal Control Officer, press #2. To schedule an appointment, make a food or public health nuisance complaint or to schedule an inspection, press #3. For Social Services, press #4, Municipal Alliance, press #5, Middlesex County Public Health Department, press #6. For public health emergencies, call 732-745-3100.

Most forms and vital statistics services, formerly available in the Health Department, are now available in the Township Clerk's Office. They include: Birth, Marriage, Civil Union and Death Certificates as well as information on licensing retail food, vending, swimming pools, day care and nursery, beauty and barbershops, food trucks, milk dairy, oneday temporary license, peddler and solicitor license, charitable clothing bin permits, landlord identity registration, pet inspection and raffle and bingo licenses. THE MARRIAGE OF ABRAHAM AND MARY TODD LINCOLN

On February 13th, in celebration of Valentine's Day and in honor of our nation's 16th president's birthday, historian Glen W. LeBoeuf will explore The Marriage of Abraham and Mary Todd Lincoln. According to Mr. LeBoeuf, it was "a strange courtship of two people of different classes, temperaments and backgrounds (North and South). They endured a life together of near poverty, tragic deaths of children, divided families, confining fame, and the bloodiest war in American history. Despite their differences, they held hands in the presidential box at Ford's Theatre, looking

forward to a peaceful, well-deserved retirement."

Mr. LeBoeuf has been a life-long student of military history, the American Civil War and the life of Abraham Lincoln. He has participated in several films, such as Glory (1990) and Gettysburg (1992). He is a member of the Civil War reenactment group, 3rd New Jersey Volunteers, the Abraham Lincoln Association, and the Lincoln Group of New York.

POLICE CHIEF KEVIN HARRIS RETIRES "Hail to the Chief"

Chief Kevin Harris, a Piscataway resident, retired from the Piscataway Police Department after 27 years of service in November 2009. Kevin is a graduate of Monmouth College and the FBI National Academy 184th Session sometimes described as the "top gun of police schools." The invitation-only program draws leaders and managers of state and local police, sheriffs' departments, military police organizations, and federal law enforcement agencies from every state in the union. Chief Harris went from patrolman to

sergeant in 1992, lieutenant in 1995, captain in 1999. He was promoted to superintendent in 2000, and in 2003 was promoted to Chief of Police.

Under his leadership and direction the highly successful Township Youth Week held in July for students in the 7th and 8th grades, and the Citizen's Police Academy were started. He is also responsible for the department's advancement in technology. Piscataway thanks him for his service and wishes him the best of luck!

The Police Department will conduct a Citizen's Police Academy beginning on February 4, 2010. The program is a 12-week interactive program for residents to become familiar with the day-to-day operations of the police department. Township residents who are 21 years of age and who successfully complete a thorough

background investigation are eligible to participate.

Participants will gain a better understanding of the procedures, guidelines, responsibilities, demands of personnel and laws and policies that guide police decision making. Overview of the department's organization and structure, recruitment and training, as well as the roles and responsibilities of the various divisions and sections will be discussed.

Citizen recruits will meet one night a week on Thursday for two hours and one selected Saturday. There is no cost and class size is limited. N.J. SENATE BILL DIRECTS DEP TO ESTABLISH A FOREST STEWARDSHIP PROGRAM

ver the past few decades, New Jersey has become the most densely populated State in the nation. As pressures, mount to develop open space for residential use, acres of forests are cleared to make way for suburban sprawl. New Jersey needs a determined effort to help forest land owners stand up to development pressures and keep the Garden State green. New Jersey Senate Bill 713 does just this. The bill directs the Department of Environmental Protection (DEP) to establish a forest stewardship program for owners of forest land who develop preservation and forest sustainability plans which meet the national forest stewardship

The Garden State is home to over two million acres of forests that are a vital source of the State's water supply. In addition, forests provide clean air by absorbing carbon dioxide and releasing oxygen, which help reduce global warming. As one of the nation's leaders in efforts to combat global warming. New Jersey must take steps to protect our greatest tool for carbon sequestration, the State's lush, green forest land. The greenhouse gas reduction goals set in 2007 and 80% by 2050. The Act shows that it

is not only possible to significantly reduce emissions but that it provides invaluable benefits both environmentally and economically.

This bill, S713, will enhance the uptake of carbon by allowing some of the State's privately owned forests to begin to regenerate, and encourage owners of private forest land to make long term plans to maintain and sustain our State's forest canopy. Forests are the most important tool in the removing carbon dioxide from the atmosphere and reversing the global warming trend, for that reason, the public has a major interest in privately owned forest lands. To provide the resources and tools to help forest owners make the ecologically friendly and socially beneficial choices to preserve forests in New Jersey, the bill provides expertise and financial incentives for those who wish to promote stewardship activities. Additionally, the bill provides for revenue generated from the Regional Greenhouse Gas Initiative auction that is allocated to forest stewardship to go towards a dedicated fund that would provide grants assisting in developing forest stewardship plans.

Forest stewardship is not only about ensuring that New Jersey has the natural resources to help remove carbon dioxide

from the atmosphere and hopefully reduce the effect of global warming, but it preserves acres of forest land for wildlife habitat and for threatened and endangered species. The protection of forests in New Jersey is essential to the environmental well being of the Garden State and necessary to ensure that our State remains green for generations to come.

Bring proof of previous rabies shot for your dog or cat. 2010 dog & cat licenses will be available. To apply for a 2010 license, the animal's rabies certificate must not expire prior to November 30, 2010 or a rabies booster will be needed. The State Department of Health recommends that pet owners revaccinate their dogs and cats every two years despite the three-year duration of immunity most vaccines provide. This recommendation is made to prevent lapses in immunity resulting from late or delayed revaccinations at the end of the three-year period.

PISCATAWAY VFW POST 7504 DISBANDS BUT WHAT A LEGACY THEY LEAVE BEHIND!

For over 44 years the Piscataway VFW Post 7504 was a meeting place for veterans who forged camaraderie with other veterans, veterans of a different generation, veterans who served in a different branch of the service, or veterans who served in a totally different war. Regardless of their age and experience they shared a common thread that only those who served, whatever the branch or wherever they served in the world could possibly understand. Together, through the years they helped one another in a myriad of ways and they often worked together to raise funds for the benefit of their community, Piscataway Township.

Like some other VFW posts, membership in Post 7504 dwindled to a handful of veterans and the post's core group decided it was time to relinquish its charter, sell the building, and cease to exist. But what to do with the proceeds of the sale? Post 7504 Piscataway residents, Sam Laudino, a Navy World War II veteran, Dominic Ciardi, a Korean War Marine veteran and Joseph Nigro, an Army Air Corp. World War II veteran elected to donate the proceeds to the municipality that was home to the post for close to 50 years. And so they did...

Recipients included: \$25,000 to the Police Department for SWAT gear; \$10,000 to Piscataway High School for an annual award to be given to three students for the best written veterans-themed essays; \$15,000 to the school's Project Graduation; \$5,000 for equipment for its robotics class and \$10,000 for a computer room at the public library. Thousands of dollars were given to help equip buses with handicapped-accessible lifts for the senior center as well as a new equipment clubhouse for the Piscataway Little League and many other causes.

Not forgotten were the veterans themselves. \$23,700 went toward television screens for the hospital rooms at the VA Hospital in Lyons; \$20,000 went to the Veterans Memorial Home in Menlo Park for a transport van, and \$2,000 went to Sgt. Eddie Ryan, 21, a soldier who lost his limbs serving in the American war on terrorism. The largest gift, \$55,000 was given to the national VFW's Operation Uplink, a program that allows American military personnel serving in Iraq, Kuwait and Afghanistan to call home and speak for up to an hour for free. More than 97 soldiers called home on Easter 2009 as a result of this donation.

Piscataway Township thanks and salutes all those veterans who were members of VFW Post 7504 and while the post is physically gone the legacy left behind guarantees it will never be forgotten.
